About Bristol Temple Quarter

One of the largest urban regeneration projects in the UK, Bristol Temple Quarter (BTQ) aims to transform more than 135 hectares of brownfield land surrounding Bristol Temple Meads into a thriving new mixed-use community, through the sustainable regeneration of the area.

Working in partnership, the programme is an opportunity to deliver around 10,000 new homes and 22,000 new jobs, alongside new infrastructure, public and greenspaces, helping to achieve sustainable and inclusive economic growth worth over £1.6 billion per year to the city-region.

£94.7m funding has already been secured from Central Government for the delivery of the programme, supporting major improvements to Bristol Temple Meads station, which sits at the heart of the regeneration area, and strategic land assembly to support the delivery of new homes and commercial space.

The programme is a partnership between four public bodies – Homes England, Bristol City Council, West of England Mayoral Combined Authority and Network Rail – and has wide-ranging political and stakeholder support across the West of England and in Whitehall.

Bristol was the first city to declare climate and ecological emergencies and BTQ will be at the forefront of sustainable regeneration at scale, meeting the city-regions ambitions for low-carbon solutions to the West of England's challenges. New travel infrastructure and low-carbon energy solutions will put BTQ at the cutting edge of what sustainable 21st century city-centre renewal can be, delivering housing and employment in large numbers of brownfield land. Developments are already underway, including a new entrance to the railway station, delivered by the partnership, and the University of Bristol's Enterprise Campus, a key catalyst for the regeneration of the wider area, due to open in Autumn 2026.

To support our ambitions, the BTQ LLP is currently procuring a private sector partner (PSP) to work alongside it. The LLP aims to have a partner selected by the end of 2025. This public/private partnership will then deliver new developments and infrastructure at Temple Quarter.

The Bristol Temple Quarter LLP

The Bristol Temple Quarter Limited Liability Partnership (BTQ LLP) was incorporated on 25 March 2024. This move formalised the longstanding collaborative approach taken by partners, Bristol City Council (BCC), Homes England (HE), Network Rail (NR), and the West of England Mayoral Combined Authority (MCA). Operating as a joint venture, BTQLLP includes BCC, HE and MCA as founding members. NR continues to work closely with BTQ LLP on the programme.

The LLP is now seeking passionate and dedicated individuals to join the team to deliver change at Temple Quarter.

This is a unique opportunity to contribute to a nationally recognized programme that aims to deliver sustainable regeneration, inclusive economic growth, and significant community benefits.

Posts will initially be offered on a fixed term or interim basis until June 2026.
